Not later than ten (10) days following his/her receipt of such notice, the applicant shall present to the Floodplain Administrator non-refundable certified funds, payable to Delta County Environmental Health Department, in the amount as set. Until the fee is paid to Delta County, the Floodplain Development Permit Application shall not be further processed.
